

Myrtle Trace Activities Committee Report

Monday – October 11, 2021

The meeting was called to order at 7:00 p.m. by Santo Perry.

Debbie Rebocho addressed the new attendees and asked them to introduce themselves. They were Brian and Cindy Smith and Fred Shields.

The Treasurer's Report: Cathy Smith advised that she had not yet received the September bank statement. She presented a balance of \$2,036.18 based on checks written, deposits made and encumbered funds since the August statement. Geralyn Hartman made a motion to accept the Treasurer's Report, seconded by Arlene Buckley and all were in favor.

Santo Perry asked if everyone had a chance to review minutes and if there were any corrections needed. Bob Smith made a motion to accept the minutes, seconded by Carol Duganier, all were in favor.

Bill Fox stated that the Nominating Committee had met today and that if anyone received a call and was asked to run for the Board that he hoped the person would say yes. Bill also advised that the Annual Meeting is scheduled to take place at Horry-Georgetown Technical College as it has in the past.

Standing Committee Report

Potluck Dinner: Cathy Smith stated that there were 16 residents in attendance at the Potluck on Monday, September 27th. She also advised that there are volunteers to chair the Potluck through next year. She stated that they are still looking for recipes for the cookbook that she and Debbie Rebocho are working on. Debbie Rebocho added that they are also looking for volunteers to help. Deb Wierman advised that she had received a call from Harry Caldwell who advised her that there was a gentleman in the Community who handled the music for over 20 years and that he was getting the music together. She further stated that she had contacted Danny, the gentleman she had arranged to do the music, and told him that the situation had changed, and he would not be needed.

Deb advised that there has been a change with regards to the menu. She has contracted with Walk On to provide sliders, cole slaw, pickles, onion strings and macaroni salad. The food will be delivered around 12:00 and there is a worker from Walk On who has volunteered to serve the food.

Valentine's Dance: Santo Perry advised that Jeff DiMaio Trio is not available on the original date but would be available on February 13th.

Shuffleboard League: Fred Shields advised that he and Brian and Cindy Smith would like to start a shuffleboard league. It is too late to start this year but would like to do it next year-March/April. They would like to have a 2-day tournament. Pat Paxson advised them to contact her with regards to the date so that she could add to the calendar. They were also advised that they would have to have a flier prepared and that they should contact Jeanie Rhodes.

Cruising: Brian Smith asked if there was a possibility of setting up a group for discussing Cruises as he has been approached by several people with regards to this. Brian was advised to contact Pat Paxson to work on a day/time for the group and that the group would not have to go through Activities.
