The food was prepared by Walk-Ons and donated by Ken and Deb Wierman. \$400 encumbered, Expenses: \$181.97. Deb and Ken Wierman volunteered to Chair this event next year.

Thanksgiving Debi Perry advised that they had gone to Costco, Sams and Chef Store to price items. She also advised that Sams had prepared mashed potatoes that she was going to buy and see how they tasted. Anne Kongvold stated that in the past Ham was also served. Deb and Ken Wierman volunteered to donate and cook 2 hams. Anne Kongvold volunteered to donate a turkey and cook it. Debbie Rebocho, Pam Rhiehardt, Cathy Smith and Debi Perry will also cook turkeys.

Holiday Decorations: Pat Paxson stated that she would like her Committee to meet after the meeting. Debbie Rebocho stated she would do the Certificates and Anne Kongvold said she had ribbon to donate. Geralyn Hartman made a motion to encumber \$200, seconded by Jean Hohenberger and all were in favor.
